

**THE QDOBA DIPTEMBER SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

SWEEPSTAKES ENTRY PERIOD: The QDOBA Diptember Sweepstakes (the “Sweepstakes”) begins at 12:00:00 AM Eastern Time (“ET”) on Tuesday, September 9, 2025 and ends at 04:00:00 AM ET on Saturday, September 20, 2025 (the “Sweepstakes Period”). Within the Sweepstakes Period, there are nine (9) Entry Periods (each, a “Entry Period”) as defined in the “Entry Periods & Prize Schedule” below. There are no Sweepstakes entries or prizes available to be won outside of the Entry Periods defined below. Entries must be received during an Entry Period to be eligible for that Entry Period’s drawing and prize. Non-winning entries for an Entry Period will not roll over to subsequent Entry Periods. Sponsor’s computer is the official timekeeping device for this Sweepstakes.

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, and Canada (excluding Quebec) (the “Eligible Territory”) who are age 18 or older at the time of entry. Participants under the age of majority in their state/province/territory of primary residence must have permission to participate from their parent/legal guardian. Void in

Puerto Rico, Guam, the U.S. Virgin Islands, Quebec, outside the U.S. and Canada, and wherever else prohibited by law. Employees of QDOBA Restaurant Corporation (the "Sponsor"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator") and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state/provincial and local laws and regulations.

HOW TO ENTER: There are two (2) ways to enter.

Method #1: Purchase Entry. During an Entry Period, participants must complete a purchase and pickup/delivery of such purchase at a QDOBA Restaurant that participates in the QDOBA Rewards program within the Eligible Territory of any of the eligible QDOBA chips & dip items listed below (each, a "Qualifying Purchase") using their standard QDOBA Rewards Member status level account to receive one (1) entry into the Sweepstakes or using their QDOBA Rewards Gold Status level account to receive two (2) entries into the Sweepstakes (each a "Purchase Entry"). Limit: One (1) Qualifying Purchase per person per Entry Period. Qualifying Purchases may be made in-restaurant or online. Qualifying Purchases placed online will earn the Purchase Entry for the Entry Period at the time the order is picked up/delivered and considered fulfilled. Qualifying Purchases made or related to the following will not earn Purchase Entry: Catering orders; 3rd-Party marketplace orders; Late loyalty account additions (e.g.: 'Forgot Visit Code' inputs) due to inability to verify purchase requirement; Transactions where item data is not trackable (e.g., 'Forgot Visit Code' orders where receipt is linked, but not items associated to confirm purchase requirement); Online orders where chips and dip were received but not paid for (e.g., sign-up reward of Free Queso & Chips with Entrée).

Method #2: Online Entry. To enter without making a Qualifying Purchase, during an Entry Period, visit www.diptember.com/amoe and follow all entry instructions to complete the entry form including providing the email address that is associated with their QDOBA Rewards Account and submit to receive two (2) entries into the Sweepstakes (the "Online Entry").

Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy, which can be found at <https://www.qdoba.com/privacy>.

Purchase Entry and Online Entry collectively referred to herein as "Entry" or "Entries". **Limit: Two (2) Entries per person per Entry Period regardless of method of entry or the number of Qualifying Purchases made.** In the event a participant submits an Online Entry and has already earned one (1) Purchase Entry for completing a Qualifying Purchase using their standard QDOBA

Rewards account, such Online Entry will earn one (1) entry into the Sweepstakes for the maximum total of two (2) Entries per person per Entry Period. All methods of entry have an equal chance of winning. All entries become the property of the Sponsor and will not be acknowledged or returned.

Day 3 Prizes: There are one hundred (100) Day 3 Prizes available to be won. Each Day 3 Prize includes one (1) "Handmade Today" Clear Tote Bag. **ARV of Day 3 Prize: \$80.43 USD/\$110.99 CAD each. Total ARV of all Day 3 Prizes: \$8,043 USD/\$11,099 CAD.**

Day 4 Prizes: There are two hundred fifty (250) Day 4 Prizes available to be won. Each Day 4 Prize includes one (1) Diptember Knit Sweater (size TBD by Sponsor based on winner preference and availability). **ARV of the Day 4 Prize: \$146.24 USD/\$201.81 CAD each. Total ARV of all Day 4 Prizes: \$36,560 USD/\$50,452.50 CAD.**

Day 5 Prizes: There are one hundred (100) Day 5 Prizes available to be won. Each Day 5 Prize includes Chips & Dip for one (1) Year. If a Day 5 Prize winner is a U.S. resident, Day 5 Prize will be awarded as one (1) \$350 USD QDOBA gift card. If a Day 5 Prize winner is a Canadian resident, Day 5 Prize will be awarded as fifty-two (52) individual Chips & Dip Reward wallet items to such winner's QDOBA Rewards account (all fifty-two (52) wallet items will be awarded at one time and have an expiration date of October 1, 2026). **ARV of Day 5 Prize: \$350 USD/\$350 CAD each. Total ARV of all Day 5 Prizes: \$35,000 USD/\$35,000 CAD.**

Day 7 Prizes: There are twenty-five (25) Day 7 Prizes available to be won. Each Day 7 Prize includes one (1) pair of Crocs with three (3) QDOBA Jibbitz (size to be chosen at time of winner confirmation). **ARV of Day 7 Prize: \$95 USD/\$131.10 CAD each. Total ARV of all Day 7 Prizes: \$2,375 USD/\$3,277.50 CAD.**

Day 9 Prize: There is one (1) Day 9 Prize available to be won. Day 9 Prize includes one (1) Queso Oil Painting by artist Noah Verrier. **ARV of Day 9 Prize: \$12,500 USD/\$17,250 CAD. Total ARV of all Day 9 Prizes: \$12,500USD/\$17,250 CAD.**

Day 10 Prizes: There are twenty-five (25) Day 10 Prizes available to be won. Each Day 10 Prize includes one (1) Chips & Dip Party Pack. If a Day 10 Prize winner is a U.S. resident, Day 10 Prize will be awarded as one (1) \$50 QDOBA digital gift card. If a Day 10 Prize winner is a Canadian resident, Day 10 Prize will be awarded as one (1) \$60 CAD digital promo code valid for one (1) Chips & Dip Party Pack. **ARV of Day 10 Prize: \$50 USD/\$60 CAD each. Total ARV of all Day 10 Prizes: \$1,250 USD/\$1,500 CAD.**

Day 11 Prize: There is one (1) Day 11 Prize available to be won. Day 11 Prize includes winner's choice of one (1) Queso Cup Whirlpool Tub with Jets (41" Long x 41" Wide x 26" Deep, 64-gallon capacity; installation not included) or \$10,000 USD/\$13,800 CAD awarded in the form of a check. **ARV: \$10,000 USD/\$13,800 CAD. Total ARV of Day 11 Prizes: \$10,000 USD/\$13,800 CAD.**

There is a limit of one (1) prize per person per Entry Period. Odds of winning will depend upon the total number of eligible entries received.

CAD Values are calculated based on the exchange rate as of September 3, 2025.

RANDOM DRAWING: The winners will be selected in a series of random drawings on or about **Wednesday, September 24, 2025** from among all eligible entries received during each Entry Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

WINNER NOTIFICATION & VERIFICATION: Potential Day 9 and Day 11 Prize winners will be notified via email and/or phone, and will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases") if winner resides in the United States or a Declaration and Release Form (the "Declaration") if winner resides in Canada. Releases will require the winner to furnish their Social Security Number for the sole purpose of tax reporting, as required by law. Noncompliance will result in disqualification and an alternate winner may be selected.

Potential Day 1, Day 2, Day 3, Day 4, Day 5, Day 7 and Day 10 winners will be notified by email and required to confirm their address as instructed within 72 hours via return email. Noncompliance will result in disqualification and an alternate winner may be selected.

If any winner is a Canadian resident, then they will be required to correctly answer a skill-based mathematical test question without mechanical or other aid (which may, in the sole and absolute discretion of the Sponsor, be administered online, by email or other electronic means, by telephone, or in the Declaration) within a limited time-period in order to be eligible to receive their prize. Not providing the answer within the required time period, providing an incorrect or incomplete answer, or noncompliance with the terms of administration of the skill-testing question will result in disqualification of the potential winner and an alternate winner may be selected. Without limiting the generality of the forgoing, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.

Prizes will be awarded within approximately 45 days after the winner is verified, with the exception of Day 7 Prizes which will begin manufacture within such time and delivered upon completion.

If a winner is otherwise eligible under these Official Rules but is nevertheless deemed a minor in their state/province of primary residence, the prize will be awarded in the name of winner's parent or legal guardian who will be required to execute and return the Releases/Declaration on minor's behalf, as applicable.

If a prize notification or prize is returned as undeliverable, or if winner is found to be ineligible or not in compliance with these Official Rules, that winner will be disqualified, and the prize may be awarded to an alternate winner in a separate random drawing. If Sponsor is unable to determine and verify a potential winner after repeated alternate drawings or if Sponsor fails to receive a sufficient number of entries to correspond to the number of prizes available to be awarded, Sponsor reserves the right to not award such prize(s).

PRIZE CONDITIONS: Prizes are not redeemable for cash, assignable, transferable and may not be substituted except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value at its discretion. Any other incidental expenses on prize not specified herein are the winner's sole responsibility.

Gift cards are not redeemable for cash and will not be replaced if lost or stolen. Gift card usage is subject to the issuing company's complete terms and conditions, including expiration dates.

Winner is responsible for all federal, state/provincial local and income taxes associated with winning prize.

Except where prohibited by law, entry and acceptance of prize constitute permission to use winner's name, prize won, hometown, likeness, video recordings, photographs, and statements for purposes of advertising, promotion and publicity (including online posting) in any and all media now or hereafter known throughout the world in perpetuity, without additional compensation, notification or permission.

In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the "Authorized Account Holder" of the e-mail address submitted at time of entry. Authorized Account Holder means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Sponsor may ask any entrant or potential winner to provide Sponsor with proof, to Sponsor's satisfaction, that such party is the authorized account holder of the email address associated with the entry. Entry materials/data that have been tampered with or altered, or mass entries or entries generated by a script, macro or use of automated devices are void. The Released Parties are not responsible for: (i) lost, late, misdirected, damaged or illegible entries; or (ii) error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry information by Sponsor on account of technical problems or traffic congestion on the Internet or at any web site or any combination thereof; or (iii) any injury or damage to entrant's or any other person's computer related to or resulting from participating in the Sweepstakes. By participating in the Sweepstakes, entrant (i) agrees to be bound by these official rules, including all eligibility requirements, and (ii) agrees to be bound by the decisions of Sponsor and the Sweepstakes Administrator, which are final and binding in all matters relating to the Sweepstakes. Failure to comply with these official rules may result in disqualification from the Sweepstakes.

Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures or any factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor. DIVERSIONS, CHANGES IN SERVICE OR ACCOMMODATIONS OR SUBSTITUTIONS, OR FOR ANY ACTS OR OMISSIONS BY ANY THIRD PARTIES BEYOND ITS REASONABLE CONTROL, INCLUDING AIR CARRIER(S) AND OTHER TRANSPORTATION COMPANIES; LODGING, RESTAURANT OR OTHER HOSPITALITY PROVIDERS; ENTERTAINMENT PROVIDERS, VENUES OR ARTISTS; OR OTHER THIRD PARTY PROVIDERS SUPPLYING ANY SERVICES OR COMPONENTS OF THE PRIZE(S) TO WINNERS AND/OR THEIR GUESTS, OR FOR ANY RESULTING INJURIES, INCLUDING MONEY DAMAGES, COSTS AND EXPENSES, PROPERTY DAMAGES, PERSONAL INJURIES OR DEATH RESULTING THEREFROM.

GOVERNING LAW AND LIMITATION OF LIABILITY: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of California, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in San Diego County, CA and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in

any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in San Diego, CA. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in San Diego, CA. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

PRIVACY: As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver their name, address and other information to third parties, including Sweepstakes Administrator, for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules, including, without limitation, the storing of your personal information for purposes of complying with record retention requirements. Any information entrant provides to Sponsor may be used to communicate with entrant in relation to this Sweepstakes or on a Sweepstakes winner's list.
